## Course outline

The Chronic Conditions of the Foot course aims to provide students with the skills and knowledge required to recognise general foot conditions, determine foot care requirements, and prepare and use basic equipment and medications for those people not requiring services of a professional podiatrist in a range of residential and community service contexts. The course provides the student with the opportunity to gain or consolidate knowledge and skills in basic foot care assessment management and referral.

The Course is supported by funding from the Australian Government Department of Health under the Chronic Disease Support Project.

## Course outcome

Upon successful completion of the course students should have the ability to:

- Revise foot pathology, anatomy and physiology
- Understand the link between chronic disease and the Foot
- Understand neurovascular assessment of the foot
- Identify a range of common conditions that affect the feet
- Perform a Seven Step Foot Screening assessment
- Understand the principles and process of performing basic foot and nail care.

## Course content

The face to face workshop includes a lecture and practical workshop activities around recognition of foot conditions, assessment, application of foot assessment tools and understanding the principles of basic foot care.

## Course structure

To achieve competency students must demonstrate successful completion of:

- Scenarios and oral questioning in the classroom
- Workplace observed practice. The student must supply evidence of providing basic foot care services to at least two people.

Workplace observed practice is a mandatory requirement for this course, workplace practice must be observed by a medical practitioner, practice manager or practice nurse or appropriate relevant supervisor that performs the identified workplace tasks as part of their role.

All workplace observed activities must be completed in accordance with work health and safety standards and infection control policies and procedure.

All workplace observed activities must be completed in accordance with workplace policies and procedures of the facility where the activity is being conducted.
